The Treasurer had circulated his report prior to the meeting. Current operating account balance \$ 61,852.48

Balance reduced with regalia stock being replenished during the last period and Concours accounts at modest deficit. Accounts from event the have all been settled now except one outstanding for St Johns Ambulance for \$622. Security deposit for the Saturday display venue has been returned in full.

Stock replenishment order for spares has been progressed. Estimated \$20k to be paid out before December 31 when stock received.

Andrew reported total number of current members is 311, with 3 new members and late renewals are still coming through.

#### Concours Judging

It is proposed to review judging criteria and basis across all categories. Initial

review has commenced but subject held over to next meeting pending presentation of review/comments and recommendations for Committee consideration.

#### Website

As presented at Canberra, webpage revision progressing and well advanced. Matters arising from previous discussions and committee communications:

o Filemaker license upgrade to cloud based multiuser – costs now confirmed at \$1,782pa. This will enable database to be maintained and accessed by Membership, Historian, and necessary Committee Executive, and will be maintained separate and independent from and webpage activities.

 Events calendar upgrade – module costs to upgrade standard calendar to more advanced capability enabling state/regional group designation, recurring activities to be scheduled, etc. confirmed to be USD149 per annum (approx. AU\$240 per annum).

<u>Motion:</u> That TRR procure the advanced calendar module for incorporation in the webpage noting the annual costs required. <u>Moved:</u> Colin Baldock <u>Seconded</u>: Steve Bradford – carried

 @tr-register.com.au email setup DDNS require additional information from TRR to provide access to server for email management. Colin has been pursuing but Steve to assist to progress.

#### o General

Colin currently working through supplier validation for listing inclusion in the webpage, car sales posting (a minor bug being rectified), past events being populated (Steve to help), parts for sale forum being set up, testing continues.

#### • 2025 Concours

Arrangements progressing as reported in Canberra Members Forum

- Flyer prepared and to be issued to Members (Colin/Steve)
   This needs to be issued promptly as early bird opportunities for accommodation are on a tight window that members need to be aware of,
- o Friday night Welcome venue locked in,
- o Discussions continuing with possible concours venues,
- Bay to Birdwood event on Sunday will be on individual entry basis if members with to participate,

- o After tour plans being finalised.

#### 2026 Concours

TSOAQ have advised National Meeting in Toowoomba will be October 9 to 17, 2026. While search continues for an organiser and state (discussion regarding Victoria and New South Wales – various regional locations), the 2026 TRR event is not to clash with these TSOAQ dates.

## **Additional Note**

Prior to Committee meeting, State Coordinators were in attendance to give an account of their state and any issues they wish to raise. The only query was in Tasmania. Hugh Maslin is asking about TR4 owners joining the club. In the constitution Full Membership is only forwarded to Sidescreen owners or potential owners. Other TR's can join as Associate members with no voting rights or purchasing of spare parts. This is how our club was set up all those years ago so please if you have TR owners wishing to join that don't have a Sidescreen please explain this to them.
